Member information in accordance with the General Data Protection Regulation (DS-GVO)

Dear Members,

According to the General Data Protection Regulation (DS-GVO), we are obliged to inform you about the purpose for which we collect, store and, if necessary, forward your personal data to third parties and what rights you have with regard to your data. We can also refer to the data protection declaration on our website www.noahgraysark.com.

In detail:

- 1. Noah Gray's Ark e.V. is responsible for data protection. We do not have to appoint a data protection officer.
- 2. Your personal data is collected for the purpose of member administration and to collect membership fees. In addition to your contact details, the data includes your name, the date of birth and death / cause of death of your child, if applicable, as well as your account details, if you have agreed to a direct debit authorization.
- 3. The collection and processing of your personal data is a necessary prerequisite for adequate and careful administrative work and communication on the basis of the declaration of membership between you and the association. It takes place on the basis of legal principles.
- 4. Your data will not be transmitted to third parties.
- 5. Your personal data will be kept in the association for at least 2 years after membership has ended.
- 6. The legal basis for data processing is
 - consent to data processing
 - the necessity to fulfill the contract and to be a member of the association
 - the fulfillment of legal obligations
- 7. You have various rights with regard to your data: You can request information about the data collected and the correction of incorrect data. You also have the right to delete the stored data. You are also entitled to the restriction of processing / blocking of the data. You can revoke your consent to data processing at any time. More information about this right of withdrawal can be found in the respective consent form.
- 8. Finally, you have the right to lodge a complaint with the competent supervisory authority if you are of the opinion that the processing of the data collected violates the DS-GVO. If you have any questions about the individual points, we are of course always available.
